- 1. This Law may be cited as the Supplementary Appropriation (July 2006 to Short title June 2007) (No. 3) Law, 2006.
- 2. The Governor in Cabinet may incur executive expenses, acquire executive assets, make equity investments or loans and undertake borrowing for the financial year ending 30 June 2007 in the amount and for the respective purposes set forth in the Schedule.
