A LAW to Amend the Revised Edition (Laws of the
Cayman Islands) Law, 1960

[]

ENACTED by the Legislature of the Cayman Islands.

1—This Law may be cited as the Revised Edition (Laws of the Cayman Islands) (Amendment) Law, 1963, and shall be read and construed as one with the Revised Edition (Laws of the Cayman Islands) Law, 1960, hereinafter referred to as the principal Law, and shall come into force retrospectively as if this Law had become Law on the 31st of December, 1963.

2—Subsection (2) of section 4 of the principal Law is hereby amended by deleting the word “consecutively”.

3—Section 7 of the principal Law is hereby amended by adding at the end of paragraph (b) the word “or” and the following paragraph—
