THE WIRELESS TELEGRAPHY (CONTROL) LAW, 1965

THE WIRELESS TELEGRAPHY (GENERAL LICENCE
CHARGES) REGULATIONS, 1965

In exercise of the powers conferred on the Administrator in Council by sections 3 and 4 of the Wireless telegraphy (Control) Law, 1965, the following Regulations are hereby made -

1-- These Regulations may be cited as the Wireless Telegraphy (General Licence Charges) Regulations, 1965, and shall come into operation on a day to be appointed by Government Notice published in the Cayman Islands.

2-- (1) In these Regulations, except so far as the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

Interpretation

“the Law” means the Wireless Telegraphy (Control) Law, 1965;

“aircraft station” means a station for wireless telegraphy established in an aircraft;

“amateur station” means a station for wireless telegraphy established and used, as a part of the self-training of the licensee in communication by wireless telegraphy, for the purpose of communication with other stations similarly established and used; and “amateur television station” shall be construed accordingly;

“coast station” means a station for wireless telegraphy on land which is established or licensed by the Government of the State in which it is situated to send and receive public correspondence and other messages to and from any ship station, but does not include a station which is licensed only to send and receive messages to and from a limited number of ship stations;

“demonstration licence” means a licence of the description specified in item 5 in Part 1 of the Schedule hereto which is granted under section 4 of the Law;

“fixed station” means a station for wireless telegraphy established at a fixed location;

“licence” means a wireless telegraphy licence granted under section 3 of the Law, not being a licence of a type wholly or mainly intended to meet the needs of persons desiring to use, in a private dwelling-house and without making any charge to other persons apparatus not designed or adapted for emission (as opposed to reception);

“private mobile radio licence” means a licence of the description specified in item 8 of Part 1 of the Schedule hereto which is granted under section 3 of the Law;

“ship station” means a station for wireless telegraphy established in a vessel which is not permanently moored;

“special service station” means a station for wireless telegraphy which provides, for the benefit of shipping generally, all or any of the following services

notices to navigators, meteorological bulletins, medical advices, standard frequencies and time signals;

“radio navigation station” means a station for wireless telegraphy which provides for the benefit of shipping generally a service to enable ships to determine their distance from, or their position or bearing in relation to, any object;

and other expressions have the same meaning as they have in the Law.

3-- (1) On every occasion when, by virtue of a term or provision in the licence, a licence of a type and description specified in Part 1 of the Schedule hereto and granted under section 3 of the Law would cease to be in force on a particular date unless a renewal fee were paid, and the licensee desires that the licence should remain in force for a further period after that date, he shall pay or before that date, in respect of the period following, a renewal fee of the amount specified in relation to that type and description of licence in the said Schedule.

Renewal fees

(2) So long as any licence of a type and description specified in Part 2 of the Schedule hereto and granted under section 3 of the Law remains in force, the licensee shall pay in advance in each year on or before the date specified in the licence, in respect of the year following, a renewal fee of the amount specified in relation to that type and description of licence in the said Schedule.

4-- On the issue or renewal of any licence granted under section 3 of the Law which is not of a type or description specified in the Schedule hereto, the licensee shall pay an issue or renewal fee of such amount as may in the particular case appear to the Postmaster to be proper.

Other issue and renewal fees.

5 -- (1) Whenever a private mobile radio licence or a demonstration licence is varied by the addition of one or more stations for wireless telegraphy to those for the time being comprised in the licence, the licensee shall pay a fee at the following rate in respect of each additional station:-

Fees on variation of certain licences.

Where the date of the variation is more than 9 months before the next date on which the licence would cease to be in force if a renewal fee were not paid ... 3. 0. 0

Where the former date is more than 6 months but not more than 9 months before the latter date ... 2. 5. 0

Where the former date is more than 3 months but not more than 6 months before the latter date ... 1. 10. 0

Where the former date is not more than 3 months before the latter date ... 0. 15. 0

(2) Whenever a licence to which regulation 4 applies (not being a licence granted in pursuance of section 6 of the Law) is so varied, the licensee shall pay a fee of such amount as may in the particular case appear to the Postmaster to be proper.

6-- On the revocation or variation of a licence no part of any fee or royalty already paid or due to be paid shall be refunded or cease to be due unless the Postmaster so determines. General.

A licence to establish and use a station for wireless telegraphy for the purpose of controlling the movement of a model vehicle, vessel or aircraft, by means of the emission of electro-magnetic energy from sending apparatus, and the reception of such energy by receiving apparatus in the model.	£1	£1
7. Police and Fire Service Licence.	A licence to establish and use sending and receiving stations for wireless telegraphy, the number whereof is not limited by the licence, for the purpose of sending and receiving spoken messages concerning the operation of Police or Fire Services.	£1	£1

A licence to establish and use, on specified frequencies not being below 30 megacycles a second, specified sending and receiving stations for wireless telegraphy for the purpose of sending and receiving spoken messages concerning the business of the licensee between the stations, or between one or some of the stations and another or others of them (not being a licence authorising the transmission of messages directly between fixed stations).
