# THE WORK PERMIT LAW, 1965 No. 36 of 1965

## WORK PERMIT LAW (EXEMPTIONS) REGULATIONS, 1966.

In exercise of the powers conferred on the Administrator in Council by section 7 of the Work Permit Law, 1965, the following Regulations are hereby made:-

- 1. These Regulations may be cited as the Work Permit Law (Exemptions) Regulations, 1966, and shall come into operation on a day to be appointed by the Administrator by Government Notice.
- 2. Notwithstanding anything to the contrary-
  - (a) any alien or British subject not belonging to the Cayman Islands who is a member of a class described in Part I of the Schedule; and
  - (b) subject to the qualification stated in regulation 4, any alien or British subject not belonging to the Cayman Islands who is a member of a class described in Part II of the Schedule,

shall be exempt from the provisions of subsection (1) of section 3 of the Law.

- 3. Notwithstanding anything to the contrary-
  - (a) any person who has in his employment any alien or British subject not belonging to the Cayman Islands who is a member of a class described in Part I of the Schedule; and
  - (b) subject to the qualification stated in regulation 4, any person who has in his employment any alien or British subject not belonging to the Cayman Islands who is a member of a class described in Part II of the Schedule.

shall be exempt from the provisions of subsection (3) of section 3 of the Law in respect of such employment.

4. The qualification referred to in paragraph (b) of regulation 2 and in paragraph (b) of regulation 3 is that the exemption granted by those provisions shall apply only in respect of such occupation or employment, as the case may be, as is directly referable to membership of the class of which the alien or British subject not belonging to the Cayman Islands in respect of whose occupation or employment exemption is alleged to apply is a member.

### SCHEDULE

(Regulations 2, 3)

#### PARTI

1. Wives of British subjects belonging to the Cayman Islands and, until remarriage, widows of such.

#### PART II

- Law 11 of 1. Diplomatic Agents as defined in the Diplomatic Agent (Immunity from Legal Process) Law, 1964.
  - 2. Consular officers and consular employees but not including persons employed on domestic duties.
  - 3. Persons in the employment in the Cayman Islands any of the following bodies, that is to say -
    - (a) the British Council, members of the domestic staff of the British Council Representative in the Cayman Islands being for this purpose deemed to be in the employment of the British Council;
    - (b) the United States Information Service:
    - (c) Economic Development Aid Missions from British Commonwealth countries and U.S.A.
    - (d) the United States Peace Corps;
    - (e) the United Kingdom Scheme for Voluntary Service Overseas;
    - (f) the Canadian Universities Service Overseas.
  - 4. Persons employed with the prior approval of the Govern-

ment of the Cayman Islands by any body incorporated or regulated directly by Law.

- 5. Persons employed in the Government Service of the Cayman Islands.
- 6. Persons in the employment in the Cayman Islands of the United Nations Organization or of any other international organization of which the Cayman Islands or the Government of the Cayman Islands is a member.
- 7. Visiting members of H.M. Armed Forces.
- 8. Persons employed on ships of non-Caymanian Registry (including dredges and tugs) in the Cayman Islands.
- 9. Persons employed by the owners or operators of aircraft (being aircraft operated on a scheduled international air service calling at the Cayman Islands or operating a scheduled air service within the Cayman Islands).
- 10. Directors, inspectors and auditors of any company, association, organization or body (incorporated or established whether in the Cayman Islands or elsewhere) which either -
  - (a) operates in or from the Cayman Islands; or
  - (b) controls any company association organization or body (incorporated or established whether in the Cayman Islands or elsewhere) which operates in the Cayman Islands

but so that exemption in respect of any such person shall cease after the expiration of one month spent in the Cayman Islands by such person, whether continuously or not, in any one calendar year unless extended by the Chief Immigration Officer.

11. Persons sent by the Government of any sovereign Power outside the Cayman Islands to inspect the mission of any office of such Power in the Cayman Islands but so that exemption in respect of any such person shall cease after the expiration of thirty days

spent in the Cayman Islands by such person, whether continuously or not, in any one calendar year, unless extended by the Chief Immigration Officer.

- 12. Lawyers, medical, dental and veterinary practitioners opticians and pharmacists (if qualified to practise in the Cayman Islands), writers (including journalists), broadcasters, sculptors and painters (excluding industrial painters), but so that exemption in respect of any such person shall cease after the expiration of thirty days spent in the Cayman Islands by such person, whether continuously or not, in any one calendar year, unless extended by the Chief Immigration Officer.
- 13. Visiting ministers of existing religious denominations registered in the Cayman Islands, namely -

The Church of Christ

The Church of God (Universal)

The Church of God

The Reorganised Church of Jesus Christ of Latter Day Saints

The Pilgrim Holiness Church

The United Church of Jamaica and Grand Cayman, (formerly the Presbytenian Church).

The General Assembly of the Church of God

The Reformed Presbyterian Church, Evangelical Synod (formerly the First Evangelical Presbyterian Church of Bosun Bay).

St. Ignatius Mission, Society of Jesuits Cayman Islands Mission of Seventh Day Adventists, The Pentecostal Church

The Baptist Churches of Cayman Brac

but so that exemption in respect of any such person shall cease after the expiration of thirty days spent in the Cayman Islands by such person, whether continuously or not in any one calendar year unless extended by the Chief Immigration Officer.

14. Persons who visit the Cayman Islands on behalf of

- a principal abroad, in connexion with the appointing of, or for the purpose of having business consultations with, a local business agent or a local distributor, but so that exemption in respect of any such person by virtue of this class shall cease after the expiration of one month spent in the Cayman Islands by such person, whether continuously or not, in any one calendar year, unless extended by the Chief Immigration Officer.
- 15. Persons who visit the Cayman Islands to inspect the plant, machinery or equipment of any factory or other industrial works, or to give technical advice on the operation of any local undertaking, business or enterprise of whatever kind, but so that exemption in respect of any such person by virtue of this class shall cease after the expiration of thirty days spent in the Cayman Islands by such person, whether continuously or not, in any one calendar year, unless extended by the Chief Immigration Officer.
