THE HOTELS AID LAW, 1955

(CAP. 66)
THE HOTELS AID REGULATIONS, 1967.

In exercise of the powers conferred upon the Administrator in Council by section 11 of the Hotels Aid Law, 1955, the following Regulations are, on the recommendation of the Licensing Board, hereby made:-

- 1. These Regulations may be cited as the Hotels Aid Regulations, 1967.
- 2. The particulars contained in every form or document prescribed by these Regulations shall be printed, typed or written thereon legibly in ink or some other indelible material.

- 3. Every application for a licence to construct or to equip a hotel shall be in the form set forth as Form 1 in the First Schedule to these Regulations and shall be accompanied by:-
 - (1) the certificate of incorporation of the Company or an authenticated copy thereof, where a company is the applicant;
 - (2) a plan drawn to a scale of not less than one inch to every 100 feet of the precinct of the hotel (or where the application relates to an extension to a hotel beyond the existing precinct, the precinct of the hotel and of the extension) on which is clearly indicated the situation of every building and structure constructed or intended to be constructed thereon;
 - (3) proper plans and drawings on a scale not smaller than one-eighth of an inch to one foot of the hotel to be constructed together with a specification indicating the dimensions of such hotel and the materials with which the same is proposed to be constructed and the estimated quantities of such of the materials as will have to be imported for such purpose;
 - (4) a full descriptive list of the articles of hotel equipment necessary to be imported for the purpose of equipping such hotel and the market value thereof at the port of shipment;
 - (5) a statement of the period within which such hotel is to be equipped or such hotel constructed or opened for business and such other particulars and information as the Licensing Board may from time to time by notification by Public Notice require for the purposes of these Regulations;
 - (6) such other documents as may be prescribed.

- 4. Every licence shall be in the form set forth as Form 2 in the First Schedule to the Regulations.
- 5. Every inventory required to be kept by section 9 of the Law shall be in the form set forth as Form 3 in the First Schedule to these Regulations.
- 6. Every licensee, shall, in the manner provided in the Second Schedule to these Regulations, within one month of the date of the importation or purchase as the case may be, legibly and permanently mark, stamp, or engrave every article of hotel equipment imported under a licence granted to him. Every licensee who fails to comply with the provisions of this Regulation shall be liable on summary conviction to a fine not exceeding fifty pounds or to imprisonment for any term not exceeding six months.
- 7. The Hotels Aid Regulations, 1955 are hereby repealed.
