THE MOTOR VEHICLES LAW

(Cap. 106)

The Motor Vehicles (Amendment) Regulations, 1967

In exercise of the powers conferred upon the Administrator in Council by section 31 of the Motor Vehicles Law the following Regulations are hereby made.

- 1. These Regulations may be cited as the Motor Vehicles (Amendment) Regulations, 1967, and shall be read and construed as one with the Motor Vehicles Regulations, 1961 (hereinafter referred to as the principal Regulations) and all amendments thereto.
- 2. Regulation 2 of the principal Regulations is hereby amended by inserting immediately after the definition of "regulation" the following definition:-

"Rent-a-car Firm" means and includes a person, partnership or company engaged in the business of letting out for hire vehicles intended to be driven by the hirer and whose name is included in the list of next set out in the Schedule.

3. Regulation 20 of the principal Regulations (as amended by Regulation 5 of the Motor Vehicles (Amendment) Regulations, 1966) is hereby amended by deleting the proviso thereto and substituting the following therefor -

"Always provided that any Rent-a-car Firm may issue, on production by any person above the age of 17 years visiting the Islands of an International Driving Certificate or a valid Driving Licence of the country in which he is domiciled, a permit (hereinafter called a "Driving permit") which shall quote the true names of the holder, number, date and place of issue of such certificate or licence, and such Driving Permit shall state the name and address of the rent-a-car firm issuing it. Before issue such Driving permit shall have affixed thereto a revenue stamp of the value of 10/- across the face of which the holder of such certificate or licence shall sign his name and

such Driving permit shall permit the holder thereto to drive a motor vehicle of the same category or class as that which he is already licensed to drive during the period of his stay in the Islands not exceeding the expiration of the current licensing year. Such person shall produce his International Driving Certificate or valid Driving Licence on demand at any time to a Police Officer.

Such Driving Permit shall be in the Form H.

- It shall be a contravention of these Regulations-
- (a) if a Rent-a-car Firm hire a car without complying with the provisions of this proviso;
- (b) if the holder of a driving permit fails to carry either on his person or in the car, the driving permit while driving;
- (c) if a Rent-a-car Firm fails to inform a hirer of his obligation to carry the driving permit while driving.
