The Wild Life Protection (Amendment) Law, 1967.

Cap. 185

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Wild Life Protection (Amendment) Law, 1967 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

Short title and commencement

2. The Wild Life Protection Law (hereinafter referred to as the principal law,) is hereby amended by inserting the following new definition in section 3 -

Amendment of section 2 of Cap. 185.

principal law.

"Game Sanctuary" means any area specified in the Third Schedule to this Law; .

3. The prinicpal law is hereby amended by inserting the following new sections -

"Game Sanctuaries

Declaration of Game Sanctuaries.

5A(1) The areas specified in the Third Schedule to this Law are hereby declared to be Game Sanctuaries.

(2) The Administrator in Council may by Order amend the Third Schedule to this Law by adding thereto or deleting therefrom any area specified in such Order.

Hunting etc. in Game Sanctuary. 5B(1) Every person who -

- (a) hunts any animal or bird in a Game Sanctuary; or
- (b) takes the nest or eggs or any bird in a Game Sanctuary; or
- (c) is found within a Game Sanctuary under circumstances showing that he was hunting any animal or bird or taking or intending to take the nest or egg of any bird; or
- (d) takes any dog into or knowingly permits any dog to enter or be in a Game Sanctuary; or
- (e) carries in a Game Sanctuary any gun, catapult or other weapon capable of being used to hunt animals or birds,

shall be guilty of an offence against this Law.

(2) Any person found in a Game Sanctuary in possession of any animal, bird, bird's nest or egg shall be deemed to have hunted such animal or taken such nest or egg in such Game Sanctuary unless the contrary be proved.".

Amendment of principal law. 4. The principal law is hereby amended by the addition of the following Schedule -

> "Third Schedule. Game Sanctuaries. MEAGRE BAY POND.

The pond is located on the 1/25,000 Grand Cayman Map Sheet 2, compiled in 1965 by the Directorate of Overseas Surveys, London from air photography flown by the Photographic Survey Corporation Ltd. 1958. On the map sheet the Meagre Bay Pond lies within the grid square which has the reference 475000 ME and 2133000 M W. The limits of the pond are defined by a line measured 300 ft. inland from the High Water Mark of the pond, which will follow the Western, Northern and Eastern sides of the pond. The Southern limit is defined by the public road which runs from Boddentown east to Breakers.

COLLIERS BAY POND.

The pond is located on the map aforesaid. It lies within the grid squares 490000 ME, 2137000 MN and also 490000 ME and 2138000 MN. The limits of the pond are defined by a line measured 300 ft. inland from the High Water Mark of the pond which will follow the Southern, Western and Northern sides of the pond. The Eastern limit is defined by the public road running from Gun Bay Village north to the Tortuga Club.".
