A Law to Amend the Dangerous Drugs Law.

Cap. 32

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Dangerous Drugs (Amendment) Law, 1967 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

Short title and commencement,

2. Section 14 of the Dangerous Drugs Law (hereinafter referred to as the principal law) is hereby amended by the addition of the following new sub-section -

"(6) Any person aggrieved by the refusal of an import authorisation under this section may, within seven days of such refusal, appeal against such re-

fusal to the Administrator in Council, whose decision shall be final".

Amendment of section 22.

- 3. (1) Section 22 of the principal law is hereby amended in subsection 2(b) as follows -
 - (i) by substituting the words "not exceeding three years" for the words "not exceeding twelve months" and the words "not exceeding two hundred pounds" for the words "not exceeding one hundred pounds" where they occur in lines 8 and 9 respectively; and
 - (ii) by substituting the words "not exceeding six years" for the words "not exceeding two years" and the words "not exceeding five hundred pounds" for the words "not exceeding two hundred and fifty pounds" where they occur in line 3 and in lines 4 and 5 of the proviso thereto.
- (2) This section shall apply retrospectively to the 31st day of December, 1963.

Repeal of Cap. 90. 4. Subsections (6), (7) and (8) of section 14 of the D_{2} ngerous Drugs Law of Jamaica are hereby repealed.
