Amendment of section 22.

3. (1) Section 22 of the principal law is hereby amended in subsection 2(b) as follows -

(i) by substituting the words "not exceeding three years" for the words "not exceeding twelve months" and the words "not exceeding two hundred pounds" for the words "not exceeding one hundred pounds" where they occur in lines 8 and 9 respectively; and

(ii) by substituting the words "not exceeding six years" for the words "not exceeding two years" and the words "not exceeding five hundred pounds" for the words "not exceeding two hundred and fifty pounds" where they occur in line 3 and in lines 4 and 5 of the proviso thereto.

(2) This section shall apply retrospectively to the 31st day of December, 1963.

Repeal of Cap. 90.

4. Subsections (6), (7) and (8) of section 14 of the Dangerous Drugs Law of Jamaica are hereby repealed.

A Law to Amend the Lobster (Restriction on Fishing) Law, 1964.

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Lobster (Restriction on Fishing (Amendment) Law, 1967 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

Short title and commencement.

2. Section 2 of the Lobster (Restriction on Fishing) Law 1964 (hereinafter referred to as the principal law) is hereby amended as follows -

Amendment of section 2 of Law 18 of 1964.

(a) by the substitution of the word "February" for the word "April" in the definition of "closed season";

(b) by the substitution of the figures and words "31st of January" for the figures and words "30th of March" in the definition of "open season";

(c) by the addition of the following new definition immediately following the definition of "open season" -

"scuba equipment" means any equipment commonly used for diving with a self-contained underwater breathing apparatus, an aqualung or any other form of underwater breathing apparatus; .

Addition of  
new section  
5A.

3. The principal law is hereby amended by the addition of the following new section immediately following section 5 -

"Prohibition of  
fishing while  
scuba diving.

5A. Any person using scuba equipment who takes, injures or destroys any lobster with a spear gun or by spear fishing in Cayman waters at any time, whether during the open season or the closed season, shall be guilty of an offence under this Law."

Addition of  
new section 8A.

4. The principal law is hereby amended by the addition of the following new section immediately following section 8 -

"Power to  
appoint Honorary Game  
Wardens.

8A The Administrator may from time to time appoint such Honorary Game Wardens as he may deem necessary or expedient for carrying out the provisions of this Law".

Amendment of  
section 9.

5. Section 9 of the principal law is hereby amended by the insertion of the words "any Honorary Game Warden" immediately following the words "any member of the

Cayman Islands Police Force" where they occur therein.
