

(ii) by inserting a new subsection immediately following subsection (4) -

"4A - A Chairman and a deputy Chairman shall be appointed by the Administrator, selected from among either the official members or the other members, as the Administrator may think fit."

3. Section 18 of the principal law is hereby amended by deleting and replacing subsection (1) as follows -

"(1) The Corporation shall in each year prepare and present on or before the 1st day of July to the Administrator a report of their proceedings during the twelve months ending on the 31st day of December of the preceding year, including a complete report of their financial position in such form as to secure the provision of separate information as respects each of the main activities of the Corporation."

A Law to Amend the Gambling Law.

(Cap 60)

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Gambling (Amendment) Law, 1967 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

2. Section 2 of the Gambling Law (hereinafter referred to as principal law) is hereby amended -

A Law to Amend the Juveniles Law, 1964.

()

1. This Law may be cited as the Juveniles (Amendment) Law, 1967 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

Short title and commencement.

2. Section 12 of the Juveniles Law, 1964 is hereby amended by the substitution of a semi-colon for the full-stop at the end thereof and by the addition of the following paragraph to subsection (1) thereof -

- “(i) awarding corporal punishment on any juvenile of the male sex not exceeding twelve strokes to be inflicted by a Sergeant of Police of the Cayman Islands Police Force with a light school cane within the precincts of a police station under the supervision of
