

the Chief of Police and in the presence of a Medical Officer who is hereby empowered to intervene at any time, before or during the execution of the sentence, to postpone or stop the same, according to his opinion of the state of health of the juvenile. The Medical Officer shall forthwith report the facts of any intervention by him to the Court which imposed the sentence and that Court may, in the presence of the juvenile, vary or annul the corporal punishment or make such other order within the provisions of this sub-section as it may deem fit and proper in the circumstances of the particular case.”.

A Law to Amend the Hotels Aid Law.

(Cap 66)

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Hotels Aid (Amendment) Law, 1967 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

Short title and commencement.

2. Section 2 of the Hotels Aid Law, (hereinafter referred to as the principal law) is hereby amended as follows-

Amendment of section 2 of Cap 66.

(a) by the insertion of the word “First” immediately preceding the word “Schedule” where it occurs in the definition of “Articles of hotel equipment”; and

(b) by deleting the words "or intended to contain" where they occur in the definition of "hotel"; and

(c) by deleting the phrase "whether or not such person is the beneficial owner of the hotel" where it occurs in the definition of "proprietor".

Addition of new section.

3. The principal law is hereby amended by the addition of a new section immediately following section 2 -

"Licensing Board.

2A(1). For the purposes of this Law there shall be established a Licensing Board which shall consist of a Member of the Executive Council appointed by the Administrator as Chairman, the Collector of Customs, the Superintendent of Public Works and three elected members nominated annually by the Legislative Assembly.

(2) The Chairman or in his absence any member of the Licensing Board voted by other members present as temporary Chairman for the particular meeting shall preside at any meeting of the Licensing Board.

(3) A quorum shall consist of the Chairman or the temporary Chairman, as the case may be, and two other members present.

(4) If for any cause there shall be no quorum the power of the Licensing Board to adjourn shall be exercised by the members present.

(5) Each member shall have one vote and the majority of members present and voting shall be the decision of the Licensing Board. In the event of an equality of votes the Chairman or temporary Chairman shall have a casting vote.

(6) Each member of the Licensing Board shall,

subject to the terms of his appointment, hold office for one year."

4. Section 3 of the principal law is hereby amended as follows -

(a) by the substitution of the words "Licensing Board" for the word "Administrator" in subsection (1); and

(b) by the insertion of the words "when complete" immediately following the word "hotel" in line four and by the deletion of the words "newly erected" in line five respectively of subsection (2);

(b) by the repeal of subsection (3).

5. Section 4 of the principal law is hereby amended by the insertion of the figure "(1)" immediately following the figure "4" and by the addition of the following new subsection -

"(2) Every such application shall state in which District as specified in the Second Schedule hereto, the hotel in question will be situated."

6. Section 5 of the principal law is hereby deleted and replaced as follows -

5(1) Notwithstanding anything to the contrary in any law, every licensee shall be entitled upon production of his licence to the proper customs officer to import into the Cayman Islands in accordance with the terms thereof such building materials or articles of hotel equipment as may be specified therein on payment of such reduced customs duties and tonnage tax as shall be applicable to the particular importation according to the provisions of this Law.

(2) Notwithstanding anything to the contrary in

"Entry of building material and equipment. Import Duty and Tonnage Tax Law (Cap 68)

any law there shall be raised, levied, collected and paid for the use of the Government of the Cayman Islands on the importation of building materials and articles of hotel equipment in accordance with the provisions of this Law such percentage only of the full customs duties and tonnage tax as would be payable, but for the provisions of this Law, varying from seven and one half per centum (7½%) to two and one half per centum (2½%), according to the District, as specified in the Second Schedule hereto, in which the hotel is situated."

Amendment of section 6.

7. Section 6 of the principal law is hereby amended as follows -

- (a) by substituting the word "ten" for the word "five" where it occurs in the third line of subsection (2) thereof; and
- (b) by deleting the phrase "the person who was the proprietor of the hotel immediately before such building commenced to be so used" wherever it occurs in subsection (2) thereof and by substituting the phrase "the person who is the proprietor of the hotel"; and
- (c) by substituting the words "five hundred pounds" for the words "one hundred pounds" where they occur in subsection (3) thereof.

Amendment of section 7.

8. Section 7 of the principal law is hereby amended by substituting the following subsection for subsection (2) -

"(2) No permit shall be granted under subsection (1) of this section until the licensee has paid to the Collector of Customs, or has given security to the satisfaction of the Collector of Customs, that he will so pay all sums which would have been payable by way of customs duty or tonnage tax but for the provisions of this Law upon the importation of

such building materials or articles of hotel equipment."

9. The principal law is hereby amended by the addition of a new section immediately following section 8 -

Amendment of section 8.

8A Every licence granted under the provisions of this Law shall be numbered seriatim commencing with the first day of January in any year and ending with the last day of December in the same year".

"Licences to be numbered.

10. Section 9 of the principal law is hereby amended by the substitution of the words "Licensing Board" for the word "Commissioner" where it occurs in the third line of subsection (3) thereof.

Amendment of section 9.

11. Section 10 of the principal law is hereby amended by the substitution of the words "Licensing Board" for the word "Commissioner" where it occurs therein.

Amendment of section 10.

12. Section 11 of the principal law is hereby amended by the substitution of the following subsection for subsection (1) -

"(1) The Administrator in Council may on the recommendation of the Licensing Board make regulations for carrying this Law into effect."

13. Section 12 of the principal law is hereby deleted and replaced as follows -

Replacement of section 12.

12. The Administrator in Council may by Order vary the Schedules to this Law".

"Power to vary Schedules.

14. The principal law is hereby amended by the addition of the following new Schedule -
