consent of the owner thereof or other lawful authority shall be guilty of an offence and shall be liable on summary conviction to imprisonment for a term not exceeding six months or to a fine not exceeding £25 and in default of payment thereof to imprisonment for a term not exceeding six months:

Provided that if the Magistrate is satisfied that the accused acted in the reasonable belief that the owner would, in the circumstances of the case, have given his consent if he had been asked therefor, the accused shall not be liable to be convicted of the offence.

(2) Any Constable may arrest without warrant any person reasonably suspected by him of having committed or attempted to commit an offence against this section.

2. The Motor Vehicles Regulations, 1961 purporting to have been made by the Administrator in Council under section 31 of the Motor Vehicles Law shall be deemed to have been so made on the 6th day of January 1962

Short title.

Date of commencement of Motor Vehicles Regulations. and to have been in full force from the said date as fully and effectually as if they had been so made on such date under the provisions of section 31 of the Motor Vehicles Law.

3. Notwithstanding any failure to comply with the provisions of the Motor Vehicles Law -

All acts done in good faith between the period 6th January, 1962 to the date of the commencement of this Law (both inclusive) by any person or body purporting to exercise the rights, acts, functions, powers and duties purported to be contained in and conferred by the said Motor Vehicles Regulations, 1961 are hereby in all respects confirmed and validated and declared to have been properly and lawfully done, and every such person or body is freed, acquitted, discharged and indemnified as well against the Queen's Most Gracious Majesty, Her Heirs and successors as against all persons whatsoever from all legal proceedings of any kind in respect of or consequent on such rights, acts, functions, powers and duties as aforesaid.
