A Law further to amend the Hotels Aid Law

Long title.

- 1. This Law may be cited as the Hotels Aid (Amendment) (No 2) Law, 1967, and shall be read and construed as one with the Hotels Aid Law (hereinafter referred to as the principal Law) and all amendments thereto.
- Short title. Cap. 66
- 2. Section 5 of the principal Law (as replaced by section 6 of the Hotels Aid (Amendment) Law 1967) is hereby amended in the following respects:-

Amendment of section 5 of Cap. 66.

- (a) by deleting from subsection (1) the words "and tonnage tax";
- (b) (i) by inserting in subsection (2) immediately

after the word "Law" in the sixth line thereof a comma, and the following words and comma,

"in addition to tonnage tax at the prescribed rates", and

(ii) by deleting the words:-

"full customs duties and tonnage tax as would be payable, but for the provisions of this Law",

and substituting therefor the following:-

"value of such materials and equipment ascertained in accordance with section 14 of the Customs Law; and".

Amendment of Section 7.

3. Sub-section (2) of Section 7 of the principal Law (as amended by Section 8 of the Hotels Aid (Amendment) Law, 1967) is hereby amended by deleting the words "or tonnage tax".

Amendment of

4. The second schedule to the principal Law (as amensecond schedule. ded by section 14 of the Hotels Aid (Amendment) Law 1967) is hereby amended by deleting therefrom the words "percentage of full Customs Duties and Tonnage tax as would be payable but for the provisions of this Law" and substituting therefor the words "duties payable".

Retrospective operation of this Law.

5. This Law shall be deemed to have come into operation on the 24th day of July, 1967.

## THE HOTELS AID LAW

Cap. 66

The Hotels Aid (Amendment) Regulations, 1967

In exercise of the powers conferred upon the Administrator by section 16 of the Hotels Aid Law the following regulations on the recommendation of the Licensing Board are hereby made -

- 1. These Regulations may be cited as the Hotels Aid (Amendment) Regulations, 1967.
- 2. The Form of Licence (Form 2) in the First Schedule to the Hotels Aid Regulations, 1967 is hereby amended by deleting the words:-

"percentage of thefull Customs Duties and Tonnage Tax would ordinarily be payable but for the provisions of this Law".

and substituting therefor the words:-

"the duties payable pursuant to section 5 of the Hotels Aid Law."
