EXPLANATORY NOTE

(This note is not part of the Regulations)

These regulations increase the port dues by 5% and introduce new dues for imports and exports that pass through the port at George Town that are not handled by the Port Authority’s equipment.

THE PORT AUTHORITY LAW (1995 REVISION)

THE PORT (AMENDMENT) (PORT DUES) REGULATIONS, 1997

The Governor in Council, in exercise of the powers conferred on him by section 13 of the Port Authority Law (1995 Revision), makes the following Regulations-

1. These Regulations may be cited as the Port (Amendment) (Port Dues) Regulations, 1997.

Title
2. In these regulations, unless the context otherwise requires, “the principal Regulations” means the Port Regulations (1995 Revision).

Interpretation
3. The principal Regulations are amended as set out in the Schedule.

Amendments - increases in port dues
4. After Regulation 113 of the principal Regulations the following regulation is inserted-

Amendment - Terminal Use Dues
- “Terminal use dues

113A. The terminal use dues for all cargo, including vehicles, coming into the port terminal facility at George Town from a ship, or leaving the facility to a ship, for the handling of which the Authority’s equipment is not used, are \$7.50 per 20-foot unit, increased proportionally according to length for units longer than 20 feet, with a minimum per unit of \$7.50.”.
