- C. Large containters wil be placed and serviced by the Department at the request of the proprietors of hotels, restaurants and large business premises and an annual fee of \$600.00 shall be payable for the use of each container in addition to the fees charged under (A) or (B).
- D. The fee for a private house or condominium units shall be paid by the person registered or deemed to be registered under the Registered Land Law (Revised) as the owner.
- E. The fee for apartments and offices shall be paid by the person having control of the whole building.
- F. The fee for a hotel, restaurant, lodging house, and business premises other than offices, shall be paid by -
 - (a) the person licensed under the Tourism Law, 1974, or taking an annual licence in respect thereof under the Trade and Business Licensing Law (Revised) (as the case may be): or
- (b) if there is no such person, then by the person having the control or management thereof.
- G. The fee for a bar shall be paid by the person who is the licensee thereof under the Liquor Licensing Law, 1974.".

In exercise of the power conferred on the Governor in Council by sections 50 and 52 of the Public Health Law, 1981, the following Regulations are hereby made -

Citation and date of commencement.

1. These Regulations may be cited as the Public Health (Garbage and Refuse Disposal) (Amendment) Regulations, 1981 and shall come into force on the 1st day of January, 1982.

Substitution of regulation 10.

Law 14 of 1973

- 2. The Garbage and Refuse disposal Regulations 1975 are amended by substituting the following for regulation 10 -
 - "10. The following scale of annual fees shall apply for garbage and refuse disposal collection in service areas and shall be paid to the Financial Secretary if the premises are in Grand Cayman or to the District Commissioner if the premises are in the Lesser Islands, within fourteen days of the 1st day of January in each year -
