THE GARBAGE AND REFUSE DISPOSAL (AMENDMENT) REGULATIONS, 1990

In exercise of the powers conferred upon the Governor by sections 50 and 52 of the Public Health Law, 1981, the following regulations are hereby made --

Citation.

1. These regulations may be cited as the Garbage and Refuse Disposal (Amendment) Regulations, 1990.

Amendment of reg.10 of the Garbage and Refuse Disposal Regs. 1975.

- 2. Regulation 10 of the Garbage and Refuse Disposal Regulations, 1975, is amended as follows -
 - (a) substitute the following for paragraph A --
 - "A. (1) Private houses and apartments

\$50.00:

Provided that the Financial Secretary may, in his discretion waive this fee in whole or in part, whether prospectively or retrospectively, if he is satisfied that, having regard to the financial circumstances of the person liable under these Regulations for payment thereof, it is equitable for him to do so.

- (2) Condominium units, which expression has the same meaning as "strata lot" in the Strata Titles Registration Law, 1973 \$100.00
- (3) Hotels up to 19 bedrooms
