3. The fee for a hotel, restaurant, lodging house, and business premises other than offices, shall be paid by-

> (a) the person licensed under the Tourism Law (1995 Revision) or 1995 Revision taking an annual licence in respect thereof under the Trade and Business Licensing Law (2001 Revision) (as the case may be); or 2001 Revision

(b) if there is no such person, then by the person having the control or management thereof.

4. The fee for a bar shall be paid by the person who is the licensee thereof 2000 Revision under the Liquor Licensing Law (2000 Revision).".

THE PUBLIC HEALTH (GARBAGE AND REFUSE DISPOSAL) (AMENDMENT) REGULATIONS, 2001

In exercise of the powers conferred by sections 49 and 51 of the Public Health Law (1996 Revision), the Governor in Council makes the following regulations -

1. These regulations may be cited as the Public Health (Garbage and Refuse Citation Disposal) (Amendment) Regulations, 2001.

2. The Public Health (Garbage and Refuse Disposal) Regulations (1999 Revision) are amended by repealing the Schedule and substituting the following schedule -
