THE PUBLIC SERVICE COMMISSION LAW [REVISED]

THE PUBLIC SERVICE COMMISSION [AMENDMENT] REGULATIONS, 1979

In exercise of the powers vested in the Governor in Council by section 7 of the above Law, the following Regulations are hereby made.

Citation.

1. These Regulations may be cited as the Public Service Commission (Amendment) Regulations, 1979.

Public Service Commission Regulations, 1975 amended.

- 2. The Public Service Commission Regulations, 1975, are hereby amended as follows -
 - A. by substituting the words "Principal Secretary (Personnel)" for the words "Principal Secretary (Establishments)" wherever they appear in the said Regulations;
 - B. in regulation 2 -
 - (a) the definition "administrative officer" -
 - (i) by deleting the words and comma "Senior Principal Secretary,"; and
 - (ii) by adding, immediately following the words "Principal Secretaries" the words "(other than the Chief Justice and the Attorney General)";
 - (b) by deleting the definition "Head of Department" and substituting the following new definition therefor —

"Head of Department" means, subject to regulation 43, in relation to any officer referred to in Column III of the First Schedule to these Regulations, the officer respectively specified in Column II of that Schedule to be such Head:

Provided however that for the purpose of Parts I, II, III and IV of these Regulations the Principal Secretary (Personnel) shall be the Head of Department for all common user officers;';

(c) by adding in their proper alphabetical sequence two new definitions as follows —

"Principal Secretary" includes the Chief Secretary, the Chief Justice, the Attorney

General and the Finiancial Secretary;'; and "salary grade" with respect to a post means the salary grade applicable to that post in the annual estimates:':

- C. in regulation 6 by deleting the full-stop at the end of subregulation (1) and adding the following new proviso -
 - " Provided that if at any meeting three Members are present but the Chairman and Deputy Chairman, if any, are absent, the Members so present may appoint one of their number to act as Chairman at that meeting and he and the other two Members present shall form a quorum.";
- D. in regulation 10 (1) by substituting the words "excluding the **Chief** Justice or a" for the words "excluding the";
- E. in regulation 17 by -
 - (a) substituting the word "on" for the word "in" in the first line thereof; and
 - (b) deleting paragraph (c) and re-numbering paragraph (d) as paragraph (c);
- F. by deleting regulation 19 and substituting the following new regulation therefor -

- "Duty of Head of 19. (1) Before making any recom-Department to mendation to the Commission under consult etc. and regulation 21, 23 (2), 27 (a), 27(c), 31(1), 32 Secretary to confer 33, 34(1) or 34(2), or making a recom-Department on mendation or rendering a report under regulation 35(1), 35(2), 52 or 53 a Head of Department who is not a Principal Secretary shall consult the Principal Secretary to whom he is responsible on such recommendation and shall submit it through such Principal Secretary who shall countersign it and add such views or comments as he considers appropriate.
 - (2) If the Chief Secretary so directs in writing, the discretions, powers and functions of a Head of Department under regulations 50, 51, 54 and 55 shall not be exercised by him in relation to any particular case of alleged misconduct specified in the direction but shall be exercised by the Chief Secretary himself or by the Principal Secretary to whom such Head of Department is responsible. Any exercise, or purported exercise, by the Head of Department of any such discretion, power or function in regard to such specified case shall be void and without any effect.":

THIRD SCHEDULE OFFICES EXCLUDED FROM CONSIDERATION BY THE PUBLIC SERVICE COMMISSION [Regulations 17, 30, 36 and 37]

- 1. Chief Justice, Judge of the Grand Court, any Magistrate, the Clerk of the Court and any other office subordinate to the Chief Justice for which a legal qualification is required
- 2. Attorney General and any office subordinate to the Attorney General for which a legal qualification is required.
- 3. Internal Auditor
- 4. Private Secretary to the Governor
- 5. Offices paid on salary scales M1 M6
- 6. Offices in the Police and Prison service
- 7. All offices the remuneration of which is made with reference to daily or hourly wage rates
- 8. All offices local appointments to which are to be made on temporary terms not exceeding six months in duration.".
