6. Regulation 8 of the principal Regulations is amended by substituting "Postmaster General or Cable and Wireless (West Indies) Limited, as the case may be," for "Post Master" in the second line.

Amendment of reg. 11.

7. Regulation 11 of the principal Regulations is amended by inserting "General or Cable and Wireless (West Indies) Limited, as the case may be," immediately after "Postmaster" in the last line.

Amendment of First Schedule.

8. The First Schedule to the principal Regulations is amended by inserting "or to use a private mobile telephone" immediately after the comma in the tenth line of the second column of item 12.

Amendment of Regulations.

9. Subject to the preceding regulations, the principal Regulations are amended by substituting "Postmaster General" for "Postmaster" and "Post Master" wherever else those latter two expressions appear.
