THE REGISTERED LAND (AMENDMENT) RULES 1995

In exercise of the powers conferred upon the Governor-in-Council by section 161 of the Registered Land Law (Revised), the following rules are made —

- 1. These rules may be cited as the Registered Land (Amendment) Rules 1995 and shall be read as one with the Registered Land Rules (Revised) (hereinafter called "the principal rules").
- 2. The Third Schedule of the principal rules shall be amended by adding the forms prescribed in the schedule hereto.
- 3. These rules shall come into operation on the 1st day of June, 1995.
