(SECTION 5 (1))

In exercise of the powers conferred upon the Governor in Council by sub-section (1) of Section 5 of the above Law, it is hereby declared that:-

- 1) It is the intention of Government to construct a public road in Block 14C, George Town Central Registration Section. The width of the road is to be 20ft. as described in the schedule herewith.
- 2) The portions of land affected and their approximate areas which are needed for the proposed road construction are as follows:-

THE SCHEDULE

Commencing at map reference 6999 782 ft. N., 1511 336 ft. E, thence in a north easterly direction for a distance of approximately 16ft. to reach map reference 6999 788 ft. N., 1511 351 ft. E.

Thence in a south easterly direction through parcel 14C 95 to reach a point on the eastern boundary of parcel 14C 95 at map reference 6999 722 ft. N., 1511 448 ft. E. Thence continuing south easterly through parcel 14C 94 to reach a point on the eastern boundary of parcel 14C 94 at map reference 6999 675 ft. N., 1511 513 ft. E.

Thence again south easterly through parcel 14C 93 to map reference 6999 605 ft. N., 1511 612 ft. E., to map reference 6999 553 ft. N., 1511 631 ft. E., to map reference 6999 529 ft. N., 1511 610 ft. E., to map reference 6999 541 ft. N. 1511 580 ft. E., to map reference 6999 550 ft. N., 1511 525 ft. E., to map reference 6999 546 ft. N., 1511 506 ft. E.

Thence in a south westerly direction through parcel 14C 93 for a distance of approximately 16 ft. to reach the north eastern corner of parcel 14C 150.

Thence southerly along the eastern boundary of parcel 14C 150 for a distance of approximately 82 ft. to reach the south eastern corner of parcel 14C 150.

Thence southerly and south westerly along the eastern boundary of parcel 14C 151 for approximate distances of 60 ft. and 25 ft. to reach the south eastern corner of parcel 14C 151.

Thence in a south westerly direction along the eastern boundary of parcel 14C 98 for a distance of approximately 135 ft. to reach the south eastern corner of parcel 14C 98.

Thence in a westerly direction along the southern boundary of parcel 14C 98 for a distance of approximately 23 ft.

Thence in a south westerly direction through parcel 14C 109 to map reference 6999 225 ft. N. 1511 377 ft. E.

Thence in a south easterly direction through parcel 14C 109 to reach a point on the southern boundary of parcel 14C 92, approximately 44 ft. south east of the south western corner of parcel 14C 92.

Thence north easterly through parcel 14C 92 to reach map reference 6999 220 ft. N., 1511 439 E., then north westerly to map reference 6999 224 ft. N., 1511 427 ft. E., to map reference 6999 231 ft. N., 1511 422 ft. E.

Thence in a generally north easterly direction 20 ft. perpendicular and parallel to the eastern boundaries of parcels 14C 98, 14C 151 and 14C 150 for distances of 142 ft., 90 ft. and 75 ft. respectively to reach map reference 6999 517 ft. N., 1511 514 ft. E.

Thence north easterly and south easterly through parcel 14C 92 for distances of approximately 31 ft. and 46 ft. respectively to reach the western boundary of parcel 14C 91, approximately 14 ft. south of the north western corner of parcel 14C 91.

Thence south easterly and north westerly through parcel 14C 91 for distances of approximately 40 ft. and 98 ft. respectively to reach map reference 6999 521 ft. N., 1511 720 ft. E.

Thence northerly across parcel 14C 90 for a distance of approximately 20 ft. to reach a point in parcel 14C 87 at map reference 6999 542 ft. N., 1511 720 ft. E.

Thence south westerly and north westerly through parcel 14C 87 to map reference 6999 532 ft. N., 1511 678 ft. E., and map reference 6999 543 ft. N., 1511 657 ft. E.

Thence in a north westerly direction through parcel 14C 87 to reach map reference 6999 612 ft., N., 1511 630 ft. E.

Thence continuing north westerly through parcel 14E 87 across marl driveway to reach a point on the eastern boundary of parcel 14C 86 at map reference 6999 625 ft. N., 1511 620 ft. E.

Thence in a north westerly direction through parcel 14C 86 to reach a point on the western boundary of parcel 14C 86 at map reference 6999 665 ft. N., 1511 562 ft. E.

Thence again north westerly through parcel 14C 85 to reach a point on the eastern boundary of parcel 14C 84 at map reference 6999 716 ft. N., 1511 490 ft. E.

Thence north westerly through parcel 14C 84 to map reference 6999 799 ft. N., 1511 370 ft. E. to map reference 6999 803 ft. N., 1511 378 ft. E. to map reference 6999 819 ft. N., 1511 371 ft. E.

Thence south westerly along the southern road reserve boundary of North Sound Road to reach the starting point.
