A LAW TO APPROPRIATE CERTAIN ADDITIONAL EXPENDITURES FOR THE SIX MONTH PERIOD ENDING 30 JUNE 2003

ENACTED by the Legislature of the Cayman Islands.

- 1. This Law may be cited as the Supplementary Appropriation (January to Short title June 2003) Law, 2003.
- 2. (1) The Financial Secretary of the Islands may pay the sums set Expenditure forth in the Schedule for defraying the charges and expenses of the Government of the Islands and for other purposes for the six month period ending 30 June 2003 and such sum is by this Law charged upon the revenue and funds of the Islands.
- (2) The appropriations provided by subsection (1) are additional to the appropriations provided by the Appropriation (January to June 2003) Law, 2002.
