**A LAW TO AMEND THE TRADE
AND BUSINESS LICENSING LAW (REVISED)**

ENACTED by the Legislature of the Cayman Islands.

Short title and date
of commencement.

1. This Law may be cited as the Trade and Business Licensing
(Amendment) Law, 1985 and shall come into force on the 1st day
of January, 1986.

Amendment of
Second Schedule.

2. The Schedule to the Trade and Business Licensing Law (Revised),
in this Law referred to as the principal Law, is amended -

- (a) in that part headed "TRADES AND TECHNICAL", by
substituting -
 - (i) "\$200" for "\$100" in the last column of item number
1;
 - (ii) "\$50" for "\$25" in the last column of item number 2;
 - (iii) "\$300" for "\$100" in the last column of item number
3;
 - (iv) "\$200" for "\$100" in the last column of item number
4;
 - (v) "\$300" for "\$100" in the last column of item number
5;
 - (vi) "\$200" for "\$100" in the last column of item number
6;

2
(vii) the following for the last three lines of item number 7 -

- “(a) up to eight hundred square feet selling area \$100
- (b) up to one thousand two hundred square feet selling area \$300
- (c) up to one thousand five hundred square feet selling area \$500
- (d) up to two thousand square feet selling area \$800
- (e) over two thousand square feet selling area \$1,250”;

(viii) “\$250” for “\$100” in the last column of item number 8;

(ix) “\$50” for “\$25” in the last column of item number 9;

(x) “\$300” for “\$100” in the last column of item number 10;

(xi) “\$50” for “\$25” in the last column of item number 11;

(xii) “\$200” for “\$100” in the last column of item number 12;

(b) in that part headed “COMMERCE”, by -

(i) substituting the following for the last two columns of number 1 -

- “being the business of storing for distribution to other persons -
- petroleum products or other fuel products, except propane gas \$50,000
- propane gas \$5,000”;

(ii) substituting “\$2,000” for “\$300” in the last column of item number 2;

(iii) adding the following in the last two columns of item number 2 immediately after the third line -

“any other person, being a company carrying on such a business, to whom a licence has been granted under subsection (1) of section 10 of the Local Companies (Control) Law (Revised) \$10,000”;

(iv) substituting “\$1,500” for “\$300” in the last column of item number 3;

(v) substituting “\$200” for “\$100” in the last column of item number 4.

Effect of s.2

3. Notwithstanding that an application for a licence, or a renewal thereof for the calendar year 1986, may have been made under the principal Law before the 1st day of January, 1986, the fees prescribed by this Law shall be deemed to be the appropriate fees required by section 6 of the principal Law.
