## The Community College (Amendment) Law, 1998

# Amendment of section 11 of the principal Law

- 4. Section 11 of the principal Law is amended-
  - (a) by repealing "calendar" and substituting "academic"; and
  - (b) by inserting the word "academic" before "year" wherever it appears.

# Amendment of section 16 of the principal Law

- 5. Section 16 of the principal Law is amended-
  - (a) in subsections (1), (2) and (3), by repealing "Principal" and substituting "President"; and
  - (b) by repealing subsection (4) and substituting the following-
  - "(4) In the temporary absence of the President, and in the absence or in the case of non-appointment of a Vice President, the Board shall appoint one of the Deans of the College to act as President; and such an appointment shall not exceed six months without the prior approval of the Minister."

#### Amendment of section 17 of the principal Law

6. Section 17 of the principal Law is amended by repealing "Deputy Principal" and substituting "Vice President" and by repealing "Principal" and substituting "President".

## Amendment of section 19 of the principal Law

7. Section 19(2) of the principal Law is amended in paragraph (g) by repealing "Principal" and substituting" President".

#### Amendment of the Schedule of the principal Law

- 8. The Schedule to the principal Law is amended-
  - (a) by repealing "Principal" wherever it appears and by substituting "President":
  - (b) by repealing "Deputy Principal" and substituting "Vice President":
  - (c) in subparagraph (c), by repealing "two" and substituting "three"; and
  - (d) by repealing subparagraph (e) and substituting the following-"(e) Deans of the College".

## A LAW TO AMEND THE COMMUNITY COLLEGE LAW (1997 REVISION)

ENACTED by the Legislature of the Cayman Islands.

- 1. This Law may be cited as the Community College (Amendment) Law, 1998.
- 2. Section 2 of the Community College Law (1997 Revision), in this Law Amendment of section 2 referred to as "the principal Law", is amended -

of the Community College Law (1997 Revision).

(a) by inserting the following definition-

"Dean" means the head of a faculty of the College; and

- (b) by repealing "Principal" and substituting "President".
- 3. Section 3 of the principal Law is amended-

Amendment of section 3 of the principal Law

- (a) in subsection (3)-
  - (i) by repealing the word "Principal" and substituting "President"; and
  - (ii) by inserting at the end of paragraph (e) "one of whom shall be a Dean of the College,"; and
- (b) in subsection (9) by repealing "six" and substituting "four".
